General Conditions

Reproduction of photographs or print materials from the archives or library, by the museum, will be consistent in appearance with the original image or document.

**The Museum of the Great Plains retains all original rights to any images or documents duplicated.**

Stipulations for Commercial Use

**Credit lines** are mandatory. Unless otherwise specified, all citations must appear as, "Courtesy of the Museum of the Great Plains," followed by the museum's internal cataloging number. For print matter, the credit should appear on the same page, or on the facing page. For visual presentations, attribution should appear in the credit roll. In the case of exhibitions, credit must appear in the exhibition area.

**Adjustments** made to an image or document provided by the Museum of the Great Plains, such as cropping, superimposition, tinting, retouching, digital enhancement, or any other alteration, must be indicated in the accompanying identification.

**Publishers** must furnish the Museum of the Great Plains, without charge, one copy of each product where the museum serves as a contributor. Use fees (see *Schedule of Fees*) are due prior to publication. The Museum of the Great Plains does not grant exclusive rights to any publisher, author, or photographer; assumes no responsibility for duplication of subjects by others; and bears no responsibility for claims by third parties.

**Waivers.** The Museum of the Great Plains, at its discretion, may waive fees for items used in non-commercial documentaries; by non-profit organizations; or by the news media. Waiver requests must be made in writing. A federal or state tax identification number must accompany the request.

**Notice: Warning Concerning Copyright Restrictions**

The copyright law of the United States (Title 17, United States Code) governs the making of photocopies or other reproductions of copyrighted material.
